Cambridge Natural History Society welcomes individuals with an interest in natural history - encompassing plants, animals, fossils, soils, climate, conservation, ecology, and related subjects.

The Society hosts in-person meetings on Thursday evenings October - April in the David Attenborough Building, New Museums Site, Pembroke Street, Cambridge featuring presentations by local experts on a broad range of topics. These are also usually streamed via Zoom and attendees are encouraged to participate in further discussions within the lecture theatre, by Zoom, or informally afterwards.

During the spring and summer months, the Society organizes field excursions to sites of local significance, giving opportunities for participants to expand their knowledge of wildlife and practise identification skills.

Each year, a local area is selected for systematic survey. Monthly visits are conducted to document observed flora and fauna.

An annual exhibition, called the *Conversazione*, provides members with an excellent forum to network, share insights, and deepen their understanding of wildlife and environmental issues.
